## ENVIRONMENTAL IMPACT ASSESMENT REPORT

The final Environmental Impact Assessment Report (EIAR) for the Tetra4 Phase 2 Gas Project was submitted to the accountable authority, the Petroleum Agency of South Africa (PASA).

As previously stated, Phase 2 of the Virginia Gas Project has not yet begun. We assure the community and all relevant stakeholders will be kept informed of all applicable information in a timely manner as part of our commitment to open and honest feedback.

An Environmental Impact Assessment Report (EIAR) is a report of the effects, if any that the proposed project would have on the environment. It was prepared to inform the Environmental Impact Assessment (EIA) process.

The EIA process ensures that environmental issues are raised when a project or plan is first discussed and that all concerns are addressed as a project gains momentum through implementation.

#### PHASE 2

- Renergen is NOT recruiting for Phase 2 yet. We are still obtaining all the necessary permitting and authorizations.
- We are busy with the regulatory requirements for Phase
- We will provide advanced notice to the community of any Phase 2 related employment opportunities.
- Phase 2's workforce will only increase by 75 people across the Johannesburg and Virginia Gas Project sites.
  The majority of these will be specialized engineering skill sets.
- Gas processing plants are highly automated and this means that there are very few employment opportunities outside of specialist engineering skill sets.
